

The Magnolia Pier Bait and Tackle Club has many pools spanning over the course of the season: the season long, weekly, and shootout tournaments. You must enter each individual tournaments to be eligible for the prize.

1. Only fish caught off the Pier will be eligible for submission. Each pool has separate leaderboards with separate payouts.
2. The Clubs entry fee's (**doesn't** provide entry into the cash pools or tournaments) it provides access all of our pool's. For the Pier Pools we will host pools for bluefish, fluke, sea robins, striped bass, etc.
3. All participants must be registered within the Magnolia Pier Bait and Tackle Club Prior to any entry into the Club Only Pools and Tournaments.
4. All fish weighed must have been caught by the individual bringing them to an employee for weigh in.
5. All fish must be caught on hook and line.
6. Each participant may not fish more than one rods at a time during Shootout Tournaments and No More than two rods during season and week-long pools.
7. All fish must adhere to New York state size regulations.
8. For the Shootout Tournaments, **ONLY KEEPER** size (according to NYS Dec regulations) fish are eligible for payout. If there is no qualifying fish submitted during that tournament the prize pool with **CARRYOVER** to the following Shootout tournament.
9. Prizes are awarded solely based on fish weight. In the event of identical weights, the first fish weighed shall be declared the winner. In the event of identical weights and times, any prize money for one or both places on the leaderboard will be divided equally between the two participants.
10. A participant may place more than once in any one category, but a participant may also place in multiple categories (for example, a participant can place first for season long, weekly, and in any pool) Only fish caught off the Pier will be available for submission.
11. By signing the entry form, the participant consents that the Magnolia Pier Bait and Tackle Challenge's may use without payment or restrictions any photographs in which he or she appears for any purpose whatsoever, including but not limited to resale, advertising, commercial, or promotional material.
12. The tournament committee has the right to refuse entry from any applicant. If an entry is refused, then 100% of the applicant's entry fee will be returned.
13. All participants are responsible for reading and following all rules and regulations set forth by the Magnolia Pier Bait and Tackle Fishing Pools.

Qualifications

- Fish MUST be caught off Magnolia Pier
- Fish MUST be legal in size and in-season
- Fish MUST be alive
- Fish MUST be weighed in, measured, and signed off by an authorized Staff member.
- Fish are measured by weight,
- Fish MUST be caught during shop hours only; 7am – 8pm est.
- Fish caught during fishing tournaments and special events still apply to the contest (must be a fishing club member for eligible submissions)
- ONLY ONE (1) FISH CAN WIN THE TOP PRIZES. The angler who catches the largest fish of each species off the Pier during the 2025 season will win the contest.
